DRIVERS EDUCATION PROGRAM

DRIVERS ED COURSE WILL BE OFFERED 4 TIMES during the school year in Martin and Indian River Counties and only 2 TIMES for St. Lucie County.

THIS IS A NON-CREDIT COURSE.

Student must be 15 years of age before the start of the 9 weeks in which they are going to enroll. Students must obtain at least a Learner's Permit and have it with them on their scheduled driving dates to be able to operate on road vehicles and receive certificate.

About 7-10 days before the course is scheduled to start, you will receive an email link from us at the email address listed on your registration. You will then create an account with the student's information, which will grant you access the online portion of this course. Once you confirm your email with that will come from notifications@teachsafe.com, you will be granted access for FREE and will be able to start AFTER the starting date you signed up for. This online course has NOTHING to do with what the student has done to receive the permit. This course gives an in depth training of our right of way theory and defensive driving techniques as well as various lifelong skills to help them be the safest and most confident driver on the road. It could help you save money on insurance as well!

MCSD, SLCS, IRCSD, Drivers Education in Cooperation with A Treasure Coast Driving School... Rules, Policies, & Procedures for full completion of program.

1. Your learners permit/license will be checked for validity after registration. You must have the learner's permit in hand when you show up for a driving date. The number must match the number on your on line registration or you may have to automatically forfeit your spot if over enrollment occurs for any 9 weeks session. No 9 weeks spots are ever transferable and you can only sign up for (1) 9 week session at a time. More than one registration automatically voids ALL registrations for ALL 9 weeks sessions.
2. Drivers Education is taken for **NO** school credit and **NO** grades received will remain on transcripts. Only **FULL** completion of this course will enable students to receive a possible insurance discount certificate. Full completion would mean all modules of the online course and completion of 2 GROUPE driving sessions.
3. There will be 2 GROUPE Driving sessions of three hours in length and will be set up later in the course. These are scheduled in groups of three, and will only happen if the student completes the online course in its entirety.
4. No Insurance discount certificate will be issued by A Treasure Coast Driving School if the online course and 2 driving session are not completed.

5. Upon completion of the online course, your information will be sent to an instructor who will contact you once they have a group of 3 students who have finished the course and are drive. They will contact you at the phone numbers provided on the initial registration. The instructor will tell you where to meet for pick up and drop off of each drive. Students **MUST HAVE** their own transportation to and from the lesson, please be on time for pick up and drop off. Our instructors have very tight schedules and they **CANNOT / WILL NOT** wait on you. **PARENTS ARE RESPONSIBLE FOR THEIR PICK UP AND WELL BEING AFTER THE 3 HOUR DRIVING SLOT IS FINISHED.**

6. FAILURE TO NOT SHOW FOR A BEHIND WHEEL APPOINTMENT WILL RESULT IN NO INSURANCE COMPLETION CERTIFICATE GIVEN. THESE TIMES ARE IMPOSSIBLE TO MAKE UP AND YOU WILL HAVE TO PAY OUTSIDE OF SCHOOL TO OBATAIN YOUR CERTIFICATE @ \$120.00 per 3 hour session. There are NO EXCEPTIONS to this rule. Sessions can be split between 2 or 3 students with costs being spread evenly to the 2 or 3 students.
